3 Matters Arising

3.1 Previous Actions

- 3.1.1 2nd January item 3.1.3 Completion of the **Business Maps** index showing the business premises with their name and trade indexed against their location in Bookham. Once completed Squiggle will print the map which then can be displayed on a new Notice Board in Lower Road Car Park. This will require a licence from MVDC. Subsequently it was determined that planning permission is no longer required. The approval for the money to support this activity will be delegated to the Treasurer in consultation with the Actioner. Once licenced the project manager for the installation of the Notice Board will be Arthur Field.

7 AGM – Lessons Learnt

It could be argued that as public money is going towards making the case for a Community Council then this could be considered somewhat unfair. However this is to current situation so instead we should take full advantage of using the local media (Look Local) and social media (Street Life) to put forward different views. Circulating different views should be shared between the BRA, BCA and Churches Together.

The decision on a Community Council boils down to whether should go for the status quo or is it necessary.

11.1 Planning

11.2 Environment

11.2.1 **Tree Planting:** Frances Fancourt gave an update on tree planting and hoped to plant a young oak which will eventually be a successor to the big oak which has suffered fire and other damage. This could be planted in memory of Brenda De Bruin, pending approval of Mole Valley District Council.

11.2.2 **Grass Verges:** Michael Agius would chasing up the cutting off grass verges in Eastwick Park Avenue.

- 11.2.3 **Bookham Signage:** The two signs at each end of the village on the A246 will need to be replaced at some time as the wooden frame is getting rotten and the surface of the sign is showing some distress. It would be good to be able to personalise the signs by putting some picture that is typically of Bookham.

- 11.2.4 **Parking at the Howard of Effingham:** The overgrown footpaths outside the school have been cleared of brambles recently but further work needs to be done. More of a problem is the parking on the bend, so that as you go west from the Vineries, if cars are parked on the bend it's quite difficult to see round the corner for oncoming traffic. Although there is hatching on the bend this seems to be ignored by a number of parked cars. One answer would be to have yellow lines but this would need to be agreed by the Effingham Parish Council, which once agreed would have to be authorised by Guildford Borough Council committee. This will take some time.
